The ballot results, including "registration number", "ballot result sequence" and "the check-in timeslot for registrants" shall be posted at the 19/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong at or before 8:00 p.m. on 9 March 2018. The registrant(s) will not be separately notified of the ballot results. The opening hours of the Sales Office on 9 March 2018 are from 11:00 a.m. to 4:00 p.m.
