Part (I) : Abstract

The sale of the specified residential properties will be divided into 2 groups (namely Group A and Group B). The persons or companies interested in purchasing any of the specified residential properties are referred to below as “the registrant(s)”. Individual or company registrants (whether in his/her own name or in joint names with any other parties) can only participate in any **ONE** group. Duplicated registration among different Groups will not be accepted and his/her/their registration in later group(s) will lapse automatically.

Part (II) : Registration
第(II)部分：登記

1. The registrant(s) must submit the following **personally** to the Sales Office at or before 4 p.m. on the day before the First Date of the Sale (“the Deadline of Submission”):-

A registrant shall not include both company(ies) and individual(s).

a) Group A Balloting

i) Balloting of Group A will take place on 9 March 2018. The ballot results, including “registration number”, “ballot result sequence” and “the check-in timeslot for registrants” shall be posted at the 19/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong at or before 8:00 p.m. on 9 March 2018. The registrant(s) will not be separately notified of the ballot results. The opening hours of the Sales Office on 9 March 2018 are from 11:00 a.m. to 4:00 p.m.

b) Group A Unit Selection

- i) The Group A registrant(s) (if the registrant is a company, then any one of its directors) shall **personally or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor attend** the 3/F lift lobby, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (the “Additional Designated Venue”) on the First Date of the Sale according to “the check-in timeslot for Group A registrants” in the aforesaid ballot results. The registrant(s) must bring along: -

The Group A registrant(s) whose identity(ies) has/have been verified by the Vendor shall be eligible to select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot result sequence. The Group A registrant(s) who arrive at the Additional Designated Venue at any time later than “the check-in timeslot for registrants” assigned in the ballot results shall not be eligible to select the specified residential properties according to the ballot results.

- ii) Group A Unit Selection will commence at 10:00 a.m. at the Sales Office on the First Date of Sale. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and Additional Designated Venue and/or facilitating smooth sale of the specified residential properties, to adjust the time of the Group A Unit Selection. Any changes to the time of the Group A Unit Selection will be announced at the Sales Office. Registrants will not be notified separately of such changes.

Group A registrant(s) must select and purchase **at least two (2) and at most four (4)** specified residential properties. If the number of specified residential properties a Group A registrant selects and purchases is more than the number of cashiers’ orders submitted, the Group A registrant shall submit on spot one cashiers’ order (of the payee and amount as stated in paragraph 1(b) above) in respect of each such

extra specified residential property to settle part of the preliminary deposit of that extra specified residential property (the balance of the preliminary deposit to be paid by cheque(s)). Where it is the turn of a Group A registrant to select specified residential properties that Group A registrant fails to make a selection as aforesaid (whether or not there does not remain a sufficient number of specified residential properties for fulfilling such criteria), such registrant will cease to be eligible for selection of any specified residential properties in the Group A Unit Selection.
